Project Decription (Proposed actions, location, and/or consequences).

The proposed Project involves the expansion of the existing Queen of the Valley community hospital over the next ten+ years with the use of a Specific Plan and Program EIR. A "specific plan" is a customized regulatory document established in order to provide a flexible means of implementing a General Plan. It provides more focused guidance and regulations and details the permitted uses of specific areas. The proposed QVHSP would govern the future development of the entire hospital campus. In addition to the QVHSP, the Program EIR will also examine "reasonable worst case" assumptions about the ultimate hospital development to address all future potential environmental impacts that could occur as the hospital expands.

The Hospital currently has 1,090,000 square feet of building area on 28.8 acres and is proposing to add 490,000 square feet of new buildings to support improved or new medical services on campus. This expansion would be accomplished in approximately five phases from 2019 to 2028+ depending on need financing. Initially four existing buildings (Marian Rooms A and B and Buildings A-C) will would be demolished to make way for accommodate new buildings. This initial work would also involve adding surface parking on the former City-owned 2.8-acre Sunset Field park property adjacent and to the northern end of the hospital grounds.

(1) Greenhouse Gas Emissions: significant GHG emissions. GHG-1 - solar panels to generate 25% of new energy use.
(2) Traffic: significant impacts at local intersections at buildout. TRA-1 - local improvements. TRA-2 - fair share contributions. TRA-3 - Traffic Control Plan. TRA-4 - provide temp parking. TRA-5 - parking structure approvals. TRA-6 - parking structures open before new buildings. TRA-7 - compliant sign info. TRA-8 - construction parking. TRA-9 - carpool info for employees.

Potentially Significant Impacts

Aesthetics: AES-1 thru AES-3 - locate staging away from residences, limit building heights, and install fencing. Air Quality: AIR-1 - limit VOCs during final phase of work. AIR-2 - diesel construction equipment will meet EPA Tier 3 emission standards. AIR-3 - emergency generators will be fueled by natural gas.

Biological Resources: BIO-1 - pre-construction nesting bird surveys. BIO-2 - pre-construction raptor nesting surveys. Cultural Resources: CUL-1 thru CUL-5 - protect archaeo and paleo resources during grading.

Geology/Soils: GEO-1 - prepare/implement geotechnical reports for future improvements. GEO-2 - certify grading plans. Hazards: HAZ-1 thru HAZ-3 - Address hazmat during grading or demolition and coordinate plans with local schools. Hydrology: HYD-1 - NPDES permitting and SWPPP. HYD-2 - WQMP with BMPs. HYD-3 - LID design for improvements.

Land Use: LUP-1 - locate and design future improvements to minimize impacts on local residents. Public Services: PS-1 thru PS-5 - pay applicable impact fees and comply with fire and police design requirements.

Tribal Resources: TCR-1 - monitoring agreement with tribal groups. TCR-2 - tribal grading monitoring.

Utilities: UTL-1 thru UTL-5 - water infrastructure and landscaping design to limit water use.

If applicable, describe any of the project's areas of controversy known to the Lead Agency, including issues raised by agencies and the public.

With respect to the proposed Project, the key issues to be resolved include decisions by the City of West Covina, as Lead Agency, as to: (1) Whether this environmental document adequately describes the potential environmental impacts of the proposed Project; (2) Whether the recommended mitigation measures and the design of the Project Design Features should be modified and/or adopted as proposed; (3) Whether the Project benefits override those environmental impacts that cannot be feasibly avoided or mitigated to a less than significant level; (4) Whether there are other mitigation measures that should be applied to the Project besides those identified in the Program EIR; and (5) Whether there are any alternatives to the proposed Project that would substantially lessen any of its significant impacts while achieving most of the basic Project objectives.

Environmental issues that have been raised during opportunities for public input regarding the Project are summarized in Section 2.2 of this Program EIR and are addressed in each relevant issue area analyzed in Section 4.1 through Section 4.15 of this Draft Program EIR. The primary areas of controversy that have been raised to date are related to the proposed construction being adjacent to residential uses, mainly traffic, parking, noise, and the phasing of construction activities.


