Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2018-0397-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Kwablah Attiogbe/Alameda County Public Works Agency.

The project is limited to temporary installation of a full capture trash treatment control device (TTCD) in Estudillo Canal.
