Project Title: Smith Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0620-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 5 miles southwest of the town of Covelo, County of Mendocino, State of California. The project is located in Sections 17 and 20, T22N, R13W, Mount Diablo Base and Meridian; in the Covelo West U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2018-0620-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Matt Smith.

The project is limited to seven (7) encroachments. All proposed encroachments are to maintain existing stream crossings that meet the conditions of this Agreement, or to upgrade undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and/or rock armoring as necessary to minimize erosion.

The notification also disclosed the use of a well as the water source for the property, and the existence of a spring. Water is not diverted from the spring for consumptive use.
