

What Is Being Planned?

The California Department of Transportation (Caltrans) is proposing to repair a failing structural steel plate pipe culvert situated at postmile 21.3, 100 feet below State Route 154 in northwest Santa Barbara County, 0.31 miles west of Paradise Road. The proposed project involves paving the



floor of the culvert with a 6 inch slab of concrete, and constructing a fish passage structure to remediate the barrier to fish passage created by stream scour at the culvert inlet. Construction of a temporary access road will require tree and vegetation removal. Temporary stream diversion and dewatering operations will be necessary within Bear Creek to complete the project.

Why This Public Notice?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This notice is to tell you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for you to read, and to offer the opportunity for a public hearing.
