Project Decription (Proposed actions, location, and/or consequences).

Proposed Actions: General Plan Amendment, Specific Plan, Specific Plan Amendment, Tentative Tract Map, and Change of Zone

Location: South of Nichols Road, east of I-15, and west of El Toro Road/Wood Mesa Court.

The Project Applicant proposes to develop an approximately 72.5-acre site with 168 single-family dwelling units on 31.1 acres; 14.5 acres of commercial retail; parks and recreational uses on 8.7 acres; drainage basins on 5.5 acres; open space on 1.6 acres; floodways on 5.6 acres; and backbone roadways on 5.3 acres.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

As more fully detailed in the Draft EIR, the Project would result in significant and unavoidable impacts to the following issue areas: 1) Air Quality (construction- and operational-related emissions that would exceed the SCAQMD Regional Thresholds); 2) Biological Resources (conflict with the MSHCP as applied to the northern 45.4 acres of the site that are exempt from the MSHCP); 3) Transportation and Traffic (direct and cumulatively-considerable impacts to study area intersections, freeway segments, freeway merge/diverge locations, and freeway mainlines that cannot be mitigated to less-than-significant levels because of one or more of the following factors: a. improvements required to achieve an acceptable Level of Service are funded by a local or regional funding program, but it cannot be assured that the improvements would be in place prior to the facilities experiencing a deficient LOS; b. although fair-share monetary contributions have been identified for the Project's cumulatively-considerable impacts, a funding program does not currently exist for the facility and it cannot be assured that required improvements would be in place prior to the facility experiencing a deficient LOS; and/or c. the affected facility is under the jurisdiction of another agency, such as Caltrans, and no funding programs exist beyond regional programs to implement improvements needed to achieve an acceptable LOS); and 4) Transportation and Traffic (direct and cumulatively-considerable impacts to Congestion Management Plan facilities that cannot be mitigated to below a level of significance for one or more of the reasons cited above).
