
The California Department of Transportation (Caltrans) is proposing to seismicly retrofit seven bridges in Merced County on State Routes 59, 140 and 152 to increase the structural integrity of the bridges in case of a seismic event. The project also proposes to widen the Los Banos Creek bridge on State Route 140 and upgrade the bridge rails to current standards.
