The Trails Master Plan is consistent with the Land Use and Community Design; Mobility; Open Space, Conservation, and Recreation; and Arts, History, Culture, and Education Elements of the city's General Plan, and implements the community's vision to have a fully connected trail system to provide more opportunities for active living and to create new, non-vehicular connections to destinations through appropriate standards and design guidelines.
