Project Title: Power Ranch Road to Recovery (Lake or Streambed Alteration Agreement No. 1600-2019-0492-R1)

Project Location (include county): The project is approximately 5.5 miles north of Redwood Valley, and approximately one mile upstream from the mouth of Corral Creek, in the County of Mendocino, State of California; Sections 4, 8, and 9, Township 17N, Range 12W; Mt. Diablo Base and Meridian, in the Redwood Valley, Calif. U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0492-R1, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Joe Scriven, representing Mendocino County Resource Conservation District.

The project is limited to 19 encroachments: the repair of five armored fill crossings; and installation/replacement of 14 culverts. Culverts and structures will be sized and designed to accommodate the 100-year flow, and culverts will match the alignment and gradient of the natural channels. Culverts placed in anadromous waters will meet fish passage criteria.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on September 5, 2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
