Project Decription (Proposed actions, location, and/or consequences).

The Wastewater Master Plan (WWMP or Proposed Program) involves numerous improvements to the City's collection system and upgrades to the Sutter Avenue Primary Treatment Plant and Jennings Road Secondary and Tertiary Treatment Plant. Collection system improvements include replacement/construction of new sewer lines and lift stations, sewer line rehabilitation, storm drain disconnection improvements, and other small pipeline rehabilitation projects. Proposed improvements at the Sutter Plant include upgrading the influent pump station and headworks facilities, and decommissioning of primary treatment and solids handling facilities. The Program also includes of three major outfall pipeline projects. Improvements at the Jennings Plant include upgrades to the secondary and tertiary treatment facilities and construction of new primary treatment and solids handling facilities.

The Proposed Program is located in the city of Modesto, a portion of north Ceres, the Beard Industrial Park District, the unincorporated community of Empire, and unincorporated "islands" in Stanislaus County that are served by agreement. The Sutter Plant is located in the southern portion of Modesto just north of the Tuolumne River. The Jennings Plant is located on City-annexed property located about 6.5 miles southwest of the City proper.

2. Questions about how the WWMP evaluated leaking pipes.

3. Future disposition of the Sutter Plant after treatment facilities have been decommissioned.

4. Potential flooding impacts at the Jennings Plant.

5. Disposition of discharges from the Cannery Segregation Outfall to the City's ranch lands.

6. Need for a new third outfall pipeline and redundancy.

7. WWMP area boundary and its relation to the Proposed and "Alternative" General Plan Update Land Use Map boundaries.
