approximately 0.9 miles southwest of the Interstate 5 and Jeffrey Road interchange within

the City of Irvine, County of Orange.

Project Description: The proposed project would provide traffic capacity enhancements by widening the Jeffrey

Road/Irvine Center Drive intersection to include additional turn/through lanes and additional bicycle lanes to improve mobility, safety, and access in the project area. The project would include removing an existing pedestrian island, removing and replacing concrete curb ramps with ADA-compliant curb ramps, relocating drainage features, replacing the sidewalks, and replacing traffic signal systems at the intersection. The proposed improvements would require relocating the existing SCE 66 kilovolt transmission tower at the northeast corner of the intersection and would also require a partial ROW acquisition of approximately 41,063

square feet.
