PROJECT DESCRIPTION: Applicant proposes the construction and operation of a new 25,000-square-foot medical office building on a 1.28-acre site in Castro Valley, California. The medical office building would be a two-story, 35-foot-high, state-of-the-art outpatient facility, with 98 surface parking spaces. The project includes a proposal to merge two existing parcels into a single parcel and to demolish the existing buildings on the site.

PROJECT LOCATIONS AND ZONING:

20630 and 20642 John Drive (APNs 084-A-0228-002-07 and -08) in Castro Valley; Castro Valley General Plan, Central Business District and Low Intensity Retail (CBD-1) and Castro Valley Central Business District Specific Plan, Subarea 1.
