DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Replace the existing dilapidated entrance kiosk in Bodie State Historic Park to provide protection the elements and rodents, and accommodate additional staff during the peak season. Additional work will include the installation of a new drive-up automatic pay machine (APM). Work will:

· Remove the existing 6'2" x 8'1" wooden entrance kiosk and dispose of offsite;

Use a small-tractor and hand tools to prepare and level a 7' x 16'6" subbase with a 6" thick (minimum) layer of 3/4" compacted certified weed free crushed rock;

Use a seml-truck and crane to install one (1) 7' x 12' prefabricated concrete building with exterior barn
wood texture and cedar shake textured roof;

If needed, paint CXT with custom color to match the historic took of the buildings in the park;

If needed, move existing stop sign 1' to increase the inbound road width to approximately 16'; and

Install one (1) drive-up Automatic Pay Machine (APM) on the exterior east wall of the CXT.
