"Cosens-Brown" THP 4-18-012-ELD

Project Location: These projects are located in El Dorado County within the watershed for Jackass Creek tributary to the North Fork Cosumnes River. Township 09N, Range 12E, Sections 11, 14, and 15 of U.S. Geological Survey (USGS) Quad maps: Camino and Sly Park; Mt. Diablo Base and Meridian.

Project: The projects are limited to 5 projects: the installation or repair of three permanent road crossings, the installation of one temporary skid, and the use of an existing water drafting site. More detailed descriptions can be found on pages 58-66 of the Cosens-Brown Timber Harvest Plan (4-18-012-ELD).
