DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:

Project will clean-up and repair facilities at the Windy Cove Day Use Area at Brannan Island State Recreation Area in order to re-open the area to public use. Project work will:

- In Day Use Area: mow the grass and remove dead and down wood;
- In the parking area: cut trees and roots out of the pavement, cut-out damaged pavement and patch with asphalt; fog coat or seal coat asphalt pavement areas and re-stripe parking lot;
- Around all facilities (camp host site, picnic sites, parking area, restroom, iron ranger fee station, and along paved trails and around signs): limb up trees and brush and make any needed repairs to water and electricity;
- At restrooms: clean and replace fixtures, doors and hardware as needed;
- At shade structure: clean and replace the bbq and replace twelve concrete picnic tables and one concrete bench;
- Replace sections of four-foot high chain link fence along top of eroded bluff, moving fencing away from bluff edge as needed;
- · Replace entrance and information signs; and
- Remove and chip trees and vegetation and broadcast on site or hauled off site for disposal.

Nesting bird surveys will be performed prior to limbing, brushing and tree removal.
