## Description of Nature, Purpose, and Beneficiaries of Project:

Project proponent will construct and install rip rap, an aluminum stairway and live plant stakes along the existing shoreline for an overall length of 90 feet for bank stabilization along the shore line of Lake Almanor. The proposed rip rap placement will be located along the existing edge of the eroded bank. Bio-tubes will be placed between the voids of the rip rap for the purpose of protecting the live plant stakes.

### Exempt Status:

The Central Valley Water Board has determined that the Project is categorically exempt from review under CEQA pursuant to California Code of Regulations, Title 14, Article 19, section 15304, Minor Alterations to Land.
