## PROJECT DESCRIPTION

This project involves field training exercises for CAL FIRE and cooperating Fire Department employees. A fuelbreak will be constructed around CAL FIRE's Pilot Hill Lookout through targeted thinning and pruning of Ponderosa and Foothill Pine, and removal of shrub species. A total of approximately 7 acres shall be treated on state property in an area which has been treated multiple times over the years under CAL FIRE ownership. Once completed, this fuel break will be maintained on an annual basis through the use prescribed fire with the main carrier of the fire being annual grasses and forbs which are expected to repopulate the site after shrubs and select trees are removed. Most of the returning tree and / or shrub species regrowth are expected to be consumed, thereby maintaining the fuel break in functional status. Minimal soil disturbance will occur because of the proposed project. No watercourses exist on or adjacent to the proposed project. An NDDB run detected no known occurrences or habitat of threatened, rare or endangered species known to occur in or adjacent to the project area. No activity will take place on any steep pitches over 50% in slope or when soils are saturated. The area shall be maintained using similar treatments in the future. AEU's Environmental Coordinator will survey the project area each year prior to training to confirm the presence or absence of threatened and/or endangered species.

## **REASONS PROJECT IS EXEMPT**

This project fits under the description for a Class 4 (Minor Alterations to Land) Categorical Exemption to CEQA.
