The Arroyo at Monrovia Station Specific Plan would facilitate the construction of a mixed use structure to include a 302-unit, six-story apartment complex with 7,080 square feet of retail flex space associated with three live/work units; 5,541 square feet of public space; and a seven-level (six-story) partially underground parking structure with 500 parking spaces. The retail flex space may be re-purposed for eight live/work units if retail does not occur. A range of studios, and one-bedroom and two-bedroom apartments are proposed. Fifteen of the residential units would be dedicated as Very Low Income affordable units.
