APPENDIX Q

Consultation and Coordination

The Bureau of Indian Affairs (BIA) is the lead agency under the National Environmental Policy Act (NEPA) for the proposed action (approval of a lease to authorize the development, construction, operation, maintenance and ultimately the decommissioning of a renewable energy generation project on the Campo Indian Reservation (Reservation). The Campo Environmental Protection Agency (CEPA) and the County of San Diego (County) are cooperating agencies. Terra-Gen is the developer and proposed lessee for the Campo Wind Facilities on the Reservation and the proponent of the Boulder Brush Facilities application pending with the County of San Diego.

Review of the proposed action by the following agencies is necessary as part of the environmental review process:

- U.S. Fish and Wildlife Service (USFWS): consultation under Section 7 of the Endangered Species Act.
- U.S. Army Corps of Engineers (USACE): issuance of a Section 404 permit under the Clean Water Act and/or authorization under a Nationwide Permit under Section 404 of the Clean Water Act
- California State Historic Preservation Office: consultation under Section 106 of the National Historic Preservation Act, as amended

A letter notifying interested parties of the proposal to prepare this Draft Environmental Impact Statement (EIS) and the date, time, and location of a public meeting was mailed on December 6, 2018, to local residents who have expressed an interest in renewable energy projects and to the following agencies:

After a minimum of 30 days, the BIA will issue a Record of Decision. The Record of Decision will document the BIA's decision to approve or disapprove the proposed action. The BIA assumes no responsibility for enforcing laws, regulations, or ordinances that are under the jurisdiction of other government agencies.

OTHER REQUIRED APPROVALS

Applicable federal, state, and Tribal laws and regulations are listed in Section 1.3 of this Draft EIS. Required permits for the Project may include but are not limited to:

- USACE: Clean Water Act: Section 404 Permit
- USFWS: Section 7, Endangered Species Act – Biological Opinion for Quino Checkerspot Butterfly
- BIA: Encroachment permit for improvements to roads held in trust by the BIA
- California Department of Transportation (Caltrans): Road crossings/encroachment permit
- San Diego Regional Water Quality Control Board: Section 401 Water Quality Certification (Boulder Brush Facilities only)
- County of San Diego: Major Use Permit(s) (Boulder Brush Facilities only)
- County of San Diego: encroachment permits

Required review will be completed by CEPA. As stated in Chapter 1, CEPA was formed to protect the health, environment, and property of the Tribe on the Campo Indian Reservation from degradation and pollution. CEPA is governed by three commissioners who are appointed to staggered 3-year terms by the Tribal Chairperson; these are subsequently ratified by the General Council.
