

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 7558 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 7558 and CLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3628 filed by DON PICKETT AND ASSOCIATES, proposing to allow the assembly and storage of equipment for the post-harvest processing of agricultural products to be sold directly to the farmer of processor on a 38.19-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The project site is located on the east side of Clovis Avenue, approximately 1,293 feet south of its intersection with North Avenue, approximately 2.27 miles east of the nearest city limits of the City of Fresno (SUP. DIST. 4) (APN 331-030-58). Adopt the Mitigated Negative Declaration prepared for Initial Study Application No. 7558, and take action on Classified Conditional Use Permit Application No, 3628 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 7558 and the draft Mitigated Negative Declaration, and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

The County of Fresno will receive written comments on the Proposed Project and Mitigated Negative Declaration from June 14, 2019 through July 14, 2019.
