NOTICE OF EXEMPTION



Project Title: Grosse Ave, El Camino Way, and Augustan Ave Sewer and Water Replacement - Dowling Ct to East Haven Dr

Project Location: Grosse Ave between Dowling Ct and El Camino Way, on El Camino Way between Grosse Ave and Augustan Ave, and on Augustan Ave between El Camino Way and East Haven Dr.

Project Description: This project is replacing improvements in Grosse Ave between Dowling Ct and El Camino Way, on El Camino Way between Grosse Ave and Augustan Ave, and on Augustan Ave between El Camino Way and East Haven Dr. The improvements include replacing approximately 240 linear feet (LF) of existing 4" and 1150 LF of existing 6" diameter water mains with new 8" diameter water mains, installing a new fire hydrant on the corner of Augustan Ave and East Haven Dr, installing approximately 525 LF of new 8" diameter and 777 LF of 10" diameter sewer pipe to replace 1163 LF of existing 10" diameter sewer main, 157 LF of 6" diameter sewer main, and 243 LF of 10" diameter sewer main that is located in an inaccessible backyard easement between Augustan Ave and Grosse Ave. Three lots will be re-plumbed (1998 Grosse Ave, 2172 Grosse Ave, and 1883 El Camino Ave) to re-route their sewer laterals to the new sewer in the street. In addition, approximately 7 water main valves, 31 water services, 28 sewer laterals will be replaced, and some storm drain repairs will be made. Two trees that are damaging the sidewalks, curb and gutter, and street will be removed. 10 pedestrian ramps will be replaced including 2 in front of the school. Streets will be reconstructed.
