The California Department of Transportation (Caltrans) proposes a maintenance project to replace four (4) culverts along State Route (SR) 88 at post mile 56.41, 56.58 (two culverts at this location), and at 58.86 in Amador County. The scope of work includes replacing the 4 Corrugated Metal Pipes (CMP) with Reinforced Concrete Pipes (RCP), installing concrete, flared end sections, and placing rock slope protection (RSP). All work will occur within Caltrans right of way. The purpose of this project is to replace the damaged and failing culverts. The project is needed to extend the service life of SR-88 and ensure motorist safety over these drainages.



General –

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact Environmental Office if project changes occur or sensitive resources discovered.

Cultural –

- If cultural resources are discovered at the job site, do not disturb the resources and immediately:
 1. Stop all work within a 60-foot radius of the discovery
 2. Protect the discovery area
 3. Notify the Engineer

The Department investigates. Do not move cultural materials or take them from the job site. Retain a qualified archeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner should be contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) which will then notify the Most Likely Descendent (MLD). At that time, the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Biology –

- If construction occurs during migratory bird nesting season (February 1 – September 30), a preconstruction bird survey will be required within 14 days before the start of construction. Contact the Environmental office 1 month prior to the start of construction to schedule the survey.
- Caltrans Standard Special Provision (SSP) 14-6.03A regarding protective radii shall be included in the construction contract. If active migratory bird nests are observed, a 100-foot buffer shall be established. For hawks a 300-foot buffer shall be established, for great grey owl a 600-foot buffer shall be established, and for bald eagle a 660-foot buffer shall be established.
- All construction activities will be limited to when the culverts are dry. The dry season is from July 1 – October 15. Caltrans Standard Special Provision 10-1.03 shall be included in the contract to restrict construction activities to the dry season.

Hazardous Waste –

- Caltrans Standard Special Provision 7-1.02K(6)(j)(iii) pertaining to earth material containing lead, shall be included in the contract.
