Project Title: Little Stream Restoration and Bank Stabilization Project (Lake or Streambed Alteration Agreement No. 1600-2019-0587-R1)

Project Location (include county): The project to be completed is located within the Martin Slough watershed, within the city of Eureka, County of Humboldt, State of California. The project is located in Section 34, T5N, R1W, Humboldt Base and Meridian; in the Eureka U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 018-252-017 and 018-252-018; latitude 40.7678 N and longitude 124.1625 W.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0587-R1, pursuant to Section 1602 of the Fish and Game Code to Terri Vroman Little.

The project is limited to one encroachment. The single proposed encroachment will remediate a stream that was altered during a storm event in the spring of 2019. The applicant modified the stream to ensure protection of infrastructure. The alteration, which occurred on the neighbor's parcel, was not completed in coordination with the property owner. This project will restore the stream function as agreed upon between the adjacent landowners. In addition, the project proposes to add some armoring to existing infrastructure to minimize the potential for damage. Work for this encroachment will include excavation, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
