

Project Title: Los Alamos Community/The Bridges Project (Streambed Alteration Agreement No. 1600-2019-0092-

Project Location: The project is located north and west of Vista Murrieta Road, east of Monroe Avenue, and south of Los Alamos Road, in the City of Murrieta, County of Riverside, State of California.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0092-R6, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Los Alamos (Murrieta) ASLI VII, L.L.L.P. The Los Alamos Community/The Bridges Project includes the development of a multi-family residential community, including internal and external circulation elements. The construction of the Project will impact 1.409 acre of stream and associated riparian habitat. Restoration and conservation of 3.8 acres of stream will occur. This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on July 18, 2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
