The Commission has chosen ten sites to be designated as historical land-marks with bronze plaques.

The sites are:

- 1. Approximate site of Gabrieleno Indian Village and burial ground at the mouth of the canyon.
- 2. Location on east side of Cerritos just south of Foothill to mark Dalton rancho site. (1860)
- 3. First kindergarten site, north side of 4th St. between Soldano and Pasadena Avenues. Site now marked only by a pepper tree.
- 4. Original kindergarten building (built between 1905 and 1910) now located northwest corner of Fourth Street and Angeleno Avenue. Present owner AUSD.
- 5. Lindley-Scott House, 720 E. Foothill Blvd., constructed 1912. Present owner George Scott Pieper and Associates.
- 6. Azusa Woman's Club, 1003 N. Azusa Avenue. Constructed 1928.
- 7. Victorian house, property of Joe Jara, 403 N. San Gabriel Ave. Constructed 1883.
- 8. Iglesia Presbyterian Church, 611 N. Alameda Avenue. Constructed 1892.

- 9. Masonic Temple, 510 N. San Gabriel Avenue. Constructed in 1907.
- 10. Wells Fargo Bank building, 700 N. Azusa Avenue, constructed in 1906.


For sites 1,2 and 3 the Commission has discussed a rock cairn type of monument to be built of native stone, perhaps by City personnel or volunteers. For the other sites a simple plaque is suggested, either on the building or in the sidewalk in front of the building; whichever is appropriate for the site.

It is estimated that ten bronze plaques will cost approximately \$1500 total, depending on style and amount of legend to be inscribed.


Letters have been sent to property owners, except City of Azusa, advising them of the Commission's proposal and requesting replies indicating their interest. The letters made it quite clear that the plan will not be implemented unless and until approved by City Council.

Plan" A" Chosen at last night's meeting




HISTORICAL PLAQUE-PROPOSAL "A" CITY OF AZUSA (HISTORICAL MARKER).

Moved by Ms. Cruz-Gonzalez, seconded by Mrs. Ochoa and carried by a 3-2 vote (Mrs. Garcia abstained due to the fact that she serves on the ROP Board: Ms. Harrington abstained because she is employed by ROP) to authorize the Assistant Superintendent, approve Business Services to contracts between the District and the East San Gabriel Valley ROP for educational services for the 2005-06 fiscal year.

This approval will allow for the timely completion of mutually-beneficial contracts for reimbursement between the District and the ROP as they become necessary.

Mr. Frick pointed to the fact that an earlier conversation was held about this building which has been at this location for a number of years. The District has looked at the sentimental value plus next steps.

Ms. Harrington stressed the need for a notice, in writing, to be sent to the Historical Society, Art Morales and the City of Azusa. Mr. Hamilton pointed out that this building is not on the Historical Society's list.

Ms. Cruz-Gonzalez declared that everything in the Resolution is good except for the last paragraph which indicates that if the District receives no declaration of interest regarding said building within the established timelines, that the Board would authorize staff to demolish the building anytime after March 31, 2006.



RECOMMENDATION TO PRESERVE THE AZUSA UNIFIED SCHOOL

DISTRICT (AUSD) OLD SCHOOLHOUSE BUILDING.

RECOMMENDATION:

The Cultural and Historic Preservation Commission is recommending that the City Council investigate the feasibility of the City moving the old schoolhouse building, currently located on AUSD property at the southeast corner of Slauson Middle School, to a City-owned site where it can be restored and adapted for re-use, possibly as a school museum.

BACKGROUND:

On May 17, it was brought to the attention of the Cultural and Historic Preservation Commission that an historic old building, the oldest still-standing schoolhouse in Azusa, was being considered for demolition by the Azusa Unified School District (AUSD). The building is being used for storage and has not been well maintained.

On October 18, 2005, a resident, Art Morales, approached the Commission, requesting that the Commission discuss the issue of the demolition of the old school building with the AUSD, hoping to convince them to save the building.

On November 15, 2005, Chairman Cornejo presented a letter to the Commission from the AUSD which informed the City and the Commission of the District's intention to remove the old school building on the Slauson Middle School property, by transfer of ownership or demolition. The letter included a Resolution which set out the provisions by which the building could be relocated, with the stipulation that the building must be removed from AUSD property at no cost to

the District. The Resolution states that the deadline for a declaration of interest in the building is March 31, 2006, with the deadline for the removal of the building from AUSD property as December 31, 2006. If the AUSD does not receive a declaration of interest in the building within the established timeline, the building could be demolished anytime after March 31, 2006.

ANALYSIS:

In order to preserve the old schoolhouse building, the City would need to submit a declaration of interest in the building to the AUSD prior to March 31, 2006, committing to relocate the building by no later than December 31, 2006. The City would then need to identify a City-owned site to which the building could be relocated. The City would need to allocate funds to move the old schoolhouse building and funds to refurbish and maintain the building.

FISCAL IMPACT:

The fiscal impacts – relocation, restoration and maintenance- are unknown at this time. No funds have been allocated for this activity.

Associate Planner/Staff Lialson for the Cultural and Historic Preservation Commission addressed Council advising that on November 1, 2005, the Azusa Unified School District notified the Commission that they were going to remove the old school building on the southeast corner of the Slauson Middle School.

S. Cole Comments

J. Rocha Presentation of Certificates

Councilmember Carrillo thanked all members of the AUSD as well as all in attendance for participating in the meeting. He expressed congratulations to the newly elected Board Members, stating that he hoped to have more joint meetings with the Board and reminded all to remember the reason for the meeting; the children.

Carrillo Comments

Councilmember Rocha Invited all in attendance to a special ceremony on Saturday, February 18, 2006, at 11:00 a.m. in front of the Azusa City Hall, to honor Jose S. Canedo, who graduated from Azusa High School in 1962. His name will be added existing plaques of Azusans Idlied during the Vietnam War.

Rocha Comments

Chairperson Chagnon advised of her experiences with the Azusa Unified School System as she is attending the Drendall Pre-Kindergarden class two times a week with her son.

Chagnon Comments

Comments were received from AUSD Boardmembers regarding the Importance of the meeting. Everyone was invited to attend a retirement celebration for Councilmember Rocha in recognition of his retirement as a teacher at Lee School.

AUSD Mbrs Comments Director of Economic and Community Development Coleman addressed City Council/Redevelopment Agency Board Members and Azusa Unified School District Board Members regarding the Joint Use Agreement and Promenade Park Facilities. He stated that the areas of discussion would include Time of Use of District-owned portion (3.5 acres) and City-owned portion (2 acres), Maintenance of Facilities, Fencing and Security, and any restrictions or special use considerations for various facilities. He noted that the ball field, fencing and hedging - community needs, ball field needs, school district needs, lighting, restrooms, storage, parking, gymnasium, and volley ball facilities could be discussed.

Dir Econ & Com Development

Lengthy discussion was held between the City Council/Redevelopment Agency Board and Azusa Unified School District Board Members regarding the Joint Use of Promenade Park by the public and by AUSD. The School Board Members expressed concern regarding the use of the area as a park during school hours due to safety reasons and stated that the park would be used by the school during school hours and the public use would commence after school and on weekends as noted in the Joint Use Agreement. Concerns were noted with regard to State Law and required acreage and the details of the Azusa Specific Plan with regard to the joint use park. Additional discussion was held regarding park size, existing joint use schools and parks within the City, security, i.e. highly secured areas vs. medium secured areas, fence heights, specific school hours, maintenance, after school programs, and a Mitigation Agreement. Additional discussion was held regarding contingency plan, definitions, compromises, etc.

Concerns & Discussion

It was consensus of the Council/Boardmembers to recess at 8:21 p.m. Council/Boardmembers reconvened at 8:31 p.m.

Recess Reconvene

It was consensus of all that the City Council/Boardmembers and the AUSD Boardmembers form subcommittees to discuss further ideas of how to handle the park issues. They should look at the Issues from both sides, look into how to compromise, look into use and time, should it be strictly school hours during the day, should there be fencing - what kind would be better, State requirements, and Specific Plan requirements, etc.

Create sub-Committees To discuss Park Issues

Preservation of the Azusa Unified School District (AUSD) Old Schoolhouse building. Discussion was held regarding the preservation of the old schoolhouse building currently located on AUSD property at the southeast corner of Slauson Middle school. The City Councilmembers explored options and asked the following questions: Is there any interest to fix up the building where it is if someone or a group would come forward and make a proposal? Could this be an ROP project? Could the AUSD use the money they plan to use to demolish the building for funding to relocate it or refurbish? Why is there no desire to keep it where it is, is it due to the maintenance of the building? Chairperson of the Azusa School Board Gonzales responded stating that AUSD will not spend educational money to refurbish the building and It is unsafe. Another question was "is there flexibility in the March 31, 2006, as the deadline for action regarding the old schoolhouse building"? Mayor Chagnon requested that School Board Members respond to question and send back to City Council,

Pres AUSD Old Schoolhouse Discussion

Discussion regarding Graffiti Abatement. City Manager Delach advised of the proposed comprehensive Graffiti Abatement Program which the City will be contracting for and stated that they seek schools participation on school property. Public Work Director/Assistant City Manager Makshanoff provided a brief overview of the Graffiti Abatement Program noting they will be contracting with a private contractor and there will be a 48 hour turn around with the removal of graffiti, they will do match paint, do private properties, and are working with the Azusa Police Department to address the problem In new ways. He addressed the Issue of access to Cal Trans, Los Angeles County Flood Control area, the Rallroad right of ways and unincorporated County areas, stating that they do not fall under the City's jurisdiction but they do have phone numbers to call and give out to public when graffiti incidents are sighted or reported In their areas. Chairperson of the Azusa School Board Gonzales advised that she would like to work with the City on Proposition 49 Issues, Before and After School Grants.



RECOMMENDATION:

That the City Council and the School Board discuss the preservation of the old schoolhouse building, currently located on AUSD property at the southeast corner of Slauson Middle School.

BACKGROUND:

On May 17, it was brought to the attention of the City Cultural and Historic Preservation Commission that an historic old building, the oldest still-standing schoolhouse in Azusa, was being considered for demolition by the AUSD. City records identify the building as the first Kindergarten building, constructed between 1905 – 1910, which was moved from its original site on Forth Street, between Pasadena Avenue and Soldano Avenue. The building is currently being used for storage and has not been well maintained.

A School District Resolution (#05-06:30) stipulates that a declaration of interest would need to be submitted to the District prior to March 31, 2006, committing to relocate the building no later than December 31, 2006.

On the City's part, the City would need to Identify a City-owned site to which the building could be relocated. The City would also need to allocate funds to move the old schoolhouse building and allocate funds to refurbish and maintain the building.

FISCAL ANALYSIS:

The estimated cost of moving the building, based on a 1,000 square foot building, is approximately \$12,000 - \$15,000. The estimated cost of locating the building and foundation on site and refurbishing the building is approximately \$85,000. The estimated cost of demolishing the old schoolhouse building, foundation and

sewer line is \$7,200. The estimated cost of demolition of the foundation and sewer line only would be \$2,500.

B. Baca Comments

Mr. Jorge V. Rosales addressed Council regarding the Status of the Pavement Management Plan, expressing his disappointment of the City's lack of communication to the residents of Azusa that the program is one year behind; he stated that the goal was to complete the program in five years and that this is the first he has heard that it has been delayed one year. As the staff considers the implementation of the remaining pavement plan that more consideration be given to minimize the demolition of streets before any pavement action takes place; he stated that there is a need for it to be sequenced much better than it was this last round. With regard to the Emerald Necklace, he applauds the City's consideration for joining this great effort of creating the vast amount of parks that are possible along the 17 mile loop that is created by the San Gabriel River and the Rio Hondo; he stated that he hopes the City Council considers joining in the efforts. With regard to the mixed use vs. all residential at Rosedale, he stated that the citizens of Azusa approved the specific plan that address transit oriented development along those two stations and even though the staff report is very generous in indicating that 20,000 to 30,000 square feet of commercial would be adequate, he doesn't agree, the plan is specific and it needs to be more in the 40,-50,000 square foot on both of the transit stations because it also encompasses the school areas, he hoped the city Council doesn't reduce it.

J. Rosales Comments

City Manager Delach commented on the Pavement Management Plan stating that when the program began, it had a late start; the bidding process took longer than expected and the first year scheduled spilled over to the second year so it was a about a year behind from the beginning. He stated that he agrees with Mr. Rosales the streets should be sequenced.

City Mgr Comments

Mr. Bill Holman, representing Azusa Land Partners addressed Council regarding item C-3 stating that he has reviewed the staff report regarding staff's interpretation of the Monrovia Nursery Specific Plan and whether or not commercial uses required by the Plan. He called attention to a letter from their attorney, Allen Matkins, which addresses their opinion on the subject. He stated that it comes to a different conclusion than the staff report. He stated that because of the location of the site in question off Foothill, staff is being too optimistic and they do not feel that is a good location for retail or commercial that could accommodate demand when the Gold Line comes through Azusa.

B. Holman Comments

Ms. Abigail Gaines addressed Council inviting all to the Neighborhood Homework House Annual Spring Silent and Live Auction on March 10th at 7 p.m. at the Heritage Café at the West Campus at the Azusa Pacific University. She stated that Comedian Michael Rainer will be the entertainment and MC. Auction items include two nights at the Mission Hills Resort in Rancho Mirage, helicopter rides, Dodger Game Tickets, and a week-end in Scottsdale Arizona. Councilmember Rocha noted that this is the same date as the Azusa City Employee Recognition Dinner and spoke about the importance of a community calendar.

Ms. Ginny Dadaian, Director of Human Relations at Azusa Pacific University, introduced students who are recipients of the Celebrate Azusa Nancy Moore Scholarship, Anna Padilla and Naomi Spanella, who said a few words to audience. Ms. Dadaian reminded all seniors that April 1st is the deadline for the Nance Moore Scholarship. Further that on March 2nd Cal Grant verification forms are due.

G. Dadaian Comments

Councilmember Carrillo congratulated the students for their achievements, he stated that continues to challenge the University to encourage more scholarships.

REPORTS, UPDATES COUNCIL BUSINESS AND ANNOUNCEMENTS-STAFF

Rpts/Updates

Public Works Director/Assistant City Manager James Makshanoff presented a status report on the Pavement Management Program. He addressed concerns regarding the process stating that they have just finished year 3, stating that about 50% of the streets in the City are paved, and year 4 and 5 are coming up. He stated that he shares Mr. Rosales' concerns regarding the program and that he and the City Engineer will get together and evaluate the process, and come up with new ideas. He presented a power point presentation showing where pavement has been completed and what's to come in 06 and 07 years. He stated that Staff is committed to finishing the program, but, they want to check streets to see if some are deteriorated and need greater attention. He talked about the methodology; he stated that they are currently doing a chip seal with multiple layers involved and it gives a durable street with a hard surface, not smooth, durable surface with a great life span. Alternatives are the 2 layers systems which are durable and quicker to lie down and give a high quality road and it won't be as invasive to the residents.

Pub Wks Dir Makshanoff Update on Pavement Management Plan

Mayor Pro-Tem Hardison questioned whether there is a plan to have Alameda Avenue stripped? City Engineer Scott responded stating that the history of that part of the street is not to stripe, it's a wide street, doesn't need to be striped, it appears that it should have a center line strip and he will be authorizing to strip. Mr. Makshanoff advised that they are thinking of repaving Alameda and Dalton with a smoother surface. Councilmember Rocha stated that he appreciates the global approach, that along with the repaving, trim trees, repair of sidewalks, repair of damaged curb and gutters and re-striping where appropriate, but he asked what the status the alleyways. Mr. Makshanoff responded that it would be brought back in the next budget year. Councilmember Carrillo asked what the strategy is for street paving. Mr. Makshanoff responded stating that it's cheaper to take care of the streets that are in fair to good condition streets first because there is not much work to be done, but, that there are problem areas that need to be taken care of as soon as possible. City Engineer Scott responded stating that the current thinking and cost effective in public works is that you do the entire sector in sequence, one part of the city at one time, round robin, the street are in good shape and resurfacing is more effective; while with the shot gun approach, you are always trying to catch up. Councilmember Carrillo suggested that staff look at the section of Vernon between First street and Gladstone which are in bad condition. Mr. Makshanoff responded stating that he would, and that they are re-evaluating them and will come back with a report.

Discussion Cncl-staff Comments

Mr. Jeff Yann of Amigos De Los Rios addressed Council providing a presentation on the Emerald Necklace Accord. He stated that it is a 17 mile core loop which centers around the San Gabriel River with multipurpose trails, urban rivers in the basin and it's objective is to bring people back to the rivers with opportunities for exercise, to bring nature back in to the cities, to restore wildlife habitat, commuting via bike trails, and to create a learning environment, are just a few. He noted some strategic locations such as Peck Park in El Monte, the San Gabriel River Discovery Center, Encanto Nature Walk, Puente Largo Bridge, which are included in the Necklace and that six cities and the Rivers and Mountains Conservancy have signed the Accord and he also noted that most of the efforts of the Agencies are to seek grant funding. He then responded to questions posed by Councilmembers regarding the Corp of Engineers, private owners and easements.

J. Yann Amigos De Los Rios Presentation

Councilmembers Hanks expressed his appreciation to Interim Chief of Police Garcia as well as the Azusa Police personnel for their efforts to save a child's life.

Hanks Comments

Councilmember Rocha requested that the meeting be adjourned in memory of the following: Margarita Avila, Becky Navarette, Abraham T. Villa, Carl Gutierrez, and Trygve Syverstad. He announced the following events: Miss Azusa, Miss Outstanding Teen on Friday, March 3rd at Citrus College, UMAYPA 8th Annual Scholarship Dance at the Azusa Woman's Club, and the Saint Frances of Rome 100th Year Celebration on March 11, 2006. Mr. Rocha read and article regarding the City of Glendora City Council blocking road and utility connection citywide into Glendora from neighboring cities.

Rocha Comments It also stated that the amendment to the City's General Plan eliminates the potential for traffic coming from the Monrovia Nursery property in Azusa and the proposed Canyon Oaks Development in San Dimas, both projects involving homes; Citrus and Sierra Madre were untargeted in the vote and emergency access is also an exception. She also advised of the planning of "City Hall On The Move" where plans are to take City Services out to the public. She announced the opening of a new business of Dr. Paul Evans, Evans Chiropractic located at 310 N. Citrus, Suite K, in Azusa. She then wished a very Happy Birthday to Councilmember Joe Rocha.

He stated that the issue came about on a request by Councilmember Carrillo due to a proposal by Azusa Land Partners and William Lyon Homes for an all-residential project for that area, bounded in the south by the Metro Gold Line tracks, on Citrus Avenue, Promenade and Palm Drive. He stated that ALP suggested to staff that an all residential project would be permitted by the Specific Plan, but when staff reviewed the plan, in text and graphics, and project records it clearly indicated that the plan intended this area to be mixed use and that an all residential project would not be in compliance with the Azusa Specific Plan for the Monrovia Nursery Project. He cited the Citizens Congress, the preparation of the Specific Plan, the resolution, and the Specific Plan itself and stated that all did point to the expectation of a mixed use in that area. He also referred to the City Attorney's letter in which he stating that any proposed development in the Transit II Neighborhood that does not feature mixed use commercial and residential will require a Specific Plan Amendment. He talked about appropriate amount of commercial space in that area and reiterated staff's opinion that an all residential use would require an amendment to the Specific Plan. He answered questions posed by Councilmember Carrillo regarding appropriate retail and services.

B. Coleman Comments

Councilmember Hanks questioned if there was a threshold of time period where if the railroad didn't get developed that they could revert back to all residential. Project Manager Bruckner responded stating that it was for a parking structure, there was a time period in which the developers were to set aside that land for the building of it. My interest in the building would be to restore it to its original condition and turn it into a learning center for the children of the community. It's location at a school site could serve as an after-school and weekend resource for the children to use computers and obtain assistance with homework.

I would like the next thirty (30) days to prepare a proposal for you to consider that would detail the restoration plans. During that time, I will work with the School District staff to address concerns regarding the sites location on school grounds, the possibility of redefining the property boundaries and purchasing the land from the District. Public Hearing Notice

Azusa Municipal Code Section 55-42 - Designation Procedure

- (6) It embodies one or more distinctive characteristics of style, type, period design, materials, detail, or craftsmanship.
- (7) It has a unique location or physical characteristics or represents an established and familiar visual feature of neighborhood, community, or the City of Azusa.
- (8) It incorporates elements that help to preserve and protect a historic place or area of historic interest in the City.
- (9) It has yielded, or may be likely to yield information important in prehistory or history.

Sec. 55-42. Designation Procedure.

Historic Landmarks, Historic Districts, Potential Historic Landmarks and Potential Historic Districts shall be established by the City Council in the following manner:

- A. Any Owner may apply for designation as a Historic Landmark or Historic District, any improvement, site, natural feature or grouping thereof which meets one or more of the Designation Criteria and which is located on said owner's property.
- B. With respect to nominations for Historic Districts, no application shall be accepted without at least fifty percent (50%) plus one of all affected properties proposed for inclusion in the Historic District consenting to such designation. Each ownership entity or distinguishable property (being the least of addresses, parcels, lots, or main structures as determined by the Commission) shall be entitled to one vote.
- C. The Commission on its own motion may initiate the identification and consideration of the nomination for designation of Potential Historic Landmarks and Potential Historic Districts that meet the criteria set forth in this article but which do not have the written consent of the property owner.
- D. Applications for nomination for Historic Landmarks, Historic Districts, Potential Historic Landmarks and Potential Historic Districts shall be made to the Commission on a form provided by the Planning Division. The nomination shall provide sufficient documentation and information indicating how the proposed Historic Landmark, Historic District, Potential Historic Landmark or Potential Historic District meets the Designation Criteria. All nominations shall be considered in a noticed public hearing as set forth herein. With respect to nominations for Historic Landmarks or Historic Districts, no application shall be accepted without the written consent of the owner of the property to which the nomination pertains. The owner may withdraw the consent prior to the City Council's final determination. Such withdrawal shall terminate the nomination proceedings for the subject property.
- E. Any alteration included in a pending nomination shall be subject to review by the Commission and City Council.
- F. Method of Noticing. All actions requiring public hearings before the Cultural and Historic Preservation Commission and City Council, shall require the following noticing requirements:
 - (1) The notice shall be mailed first-class and postage prepaid to the applicant; to the property owner or the owner's agent; to all persons whose names and addresses appear on the latest available assessment roll of the County of Los Angeles as owners of property within a distance of three hundred (300) feet from the exterior boundaries of the property for which the application is filed; to anyone filing a

- written request for notification; and to such other persons whose property might, in the director's judgement, be affected by the Commission's action.
- (2) The notice shall be published at least ten (10) calendar days prior to the date of the hearing in a newspaper having general circulation in Azusa.
- G. Content of Notice. The notice shall include the time, place, identity of the hearing body, nature of the application, and the general location of the property under consideration.
- H. Evidence of Notice. When notice of hearing is given pursuant to this division, the following documentation shall be deemed sufficient to serve as proof that such notice was given:
 - (1) Publication. When notice is given by publication, an affidavit of publication by the newspaper in which the publication was made.
 - (2) Mailing. When notice is given by mail or other delivery, an affidavit or proof of mailing/delivery must be made, showing, at a minimum, the date or dates of mailing/delivery and the list of persons and groups to which the mailing/delivery was made.
 - (3) Failure to send any notice by mail to any affected Owner where the address of such Owner is not a matter of public record shall not invalidate any proceedings in connection with the proposed designation. The Commission and City Council may also give such additional notice as they may deem desirable and practicable.
- Hearing Procedures.
 - (1) Scheduling of Hearings.
 - a. For applications requiring public hearing before the Cultural and Historic Preservation Commission, the Director of Community Development shall set the date and time of the hearing which shall be within thirty (30) days following the receipt of a completed application.
 - b. For applications requiring public hearing before the City Council, the City Clerk shall set the date and time of the hearing which shall be within thirty (30) days following the receipt of the Commission's resolution recommending nomination, or the filing of an appeal from the Commission's resolution denying nomination.
 - (2) Right of Persons to Comment.
 - a. During any public hearing, the applicant for the subject application shall have the following rights:
 - (1). To be represented;
 - (2). To provide testimony;
 - (3). To present evidence; and
 - (4). To ask questions of opposing witnesses.
 - b. All other persons shall have the right to comment on any relevant aspect of the application under consideration.
 - (3) Action of Hearing Body and Continuance of Hearings.
 - a. Following the completion of testimony at a public hearing, action shall be

- taken to approve, conditionally approve, deny, continue or take under advisement the subject of the public hearing.
- b. If the action is to continue or take the matter under advisement, before adjournment or recess the person presiding at such public hearing shall publically announce the time and place to which the hearing will be continued. No further notice shall be required.
- (4) Conditions may be imposed. The Cultural and Historic Preservation Commission and City Council shall have the authority to impose reasonable and necessary conditions on an application to ensure that the contemplated action complies with the provisions of this Article, the Municipal Code, the policies of the General Plan and the policies adopted by the City Council.
- (5) Notice of Decision.
 - a. Following the rendering of a decision on an application, a copy of the decision and the findings associated with that decision shall be mailed to the applicant at the address shown on the application.
 - b. Each decision by the Cultural and Historic Preservation Commission authorizing or denying an application shall be recorded as a formal and numbered resolution.

BACKGROUND:

The 1980 – 2004 City of Azusa General Plan included an Historic Preservation Element. This Historic Preservation Element included a survey list of historic properties and buildings that should be preserved. The list identified the "Old School House", the oldest still-standing schoolhouse in Azusa, originally on Fourth Street between Soldano Avenue and Pasadena Avenue and later moved to 403 N. Angeleno Avenue, as a building to be preserved. In 2000, as part of a new Historic Preservation Chapter of the Municipal Code, the Commission drafted a new survey list. The "Old School House" was inadvertently omitted from this list.

On May 17, it was brought to the attention of the Cultural and Historic Preservation Commission that the "Old School House", was being considered for demolition by the Azusa Unified School District (AUSD). The building is currently being used for storage and has not been well maintained. On November 15, 2005, Chairman Cornejo presented a letter to the Commission from the AUSD which informed the City and the Commission of the District's intention to remove the old school building, by transfer of ownership or demolition. The letter included a Resolution which set out the provisions by which the building could be relocated, with the stipulation that the building must be removed from AUSD property at no cost to the District. The Resolution states that the deadline for a declaration of interest in the building was March 31, 2006, with the deadline for the removal of the building from AUSD property as December 31, 2006. If the AUSD does not receive a declaration of interest in the building within the established timeline, the

building could be demolished anytime after March 31, 2006. The March 31, 2006 deadline passed without any action by the AUSD.

On September 19, 2006, the Commission directed Staff to agendize the nomination of the Old School House. On November 14, 2006 the City received a letter from the Superintendent of the AUSD requesting that the meeting be cancelled because they had not had time to discuss the Commission's proposal with the School Board. On October 6, 2000, the City of Azusa approved Chapter 55 of the Azusa Municipal Code – Historic Preservation, Article II, Section 55–49.A – Special Review for Potential Historic Landmarks and Potential Historic Districts requiring that: "Any alteration or demolition to be conducted at Potential Historic Landmarks and/or Potential Historic Districts shall be reviewed by the Commission prior to commencing any such work to assist the property owner in maintaining the significance of the resource and to address issues of appropriateness and designation, excluding any alterations contained in the exceptions below."

On November 1, 2006, the applicant Fred Diaz, Architect, submitted plans for an interior tenant improvement and new exterior windows for the second floor of the Bashful Butler catering business, located at 124 E. Santa Fe Avenue. This building is included on the list of Potential Historic Landmarks, therefore the Commission is reviewing the application.

Some of the windows have already been installed. The newly installed windows are very similar in design to the old windows. However, the new

windows are not all the same size as the original windows. The applicant is requesting Commission approval of the previously installed windows and approval of any new window installation.

Analysis

The newly installed windows are similar to the original windows and the original window openings in the brick building have been utilized. However, the newly installed windows have not been finished with window surrounds.

Staff is recommending that the Commission find that the new windows are similar to the old windows and therefore approve the previously installed windows and any new windows of this design, with the condition that the applicant/property owner installs window surrounds around any new windows, painted green to match the trim on the front elevation.

The District is in receipt of a letter from Susan Cole dated January 3, 2007 indicating that the City of Azusa Cultural and Historic Preservation Commission unanimously agreed on December 19, 2006, to recommend to the City Council that the "Old School House", located at 403 N. Angeleno Avenue, be added to the City of Azusa Potential Historic Landmark list. This action was taken in spite of a District letter objecting to the scheduled meeting dates and City Staff recommendations of a continuance to a future date. It is our understanding that the City Council will be holding a public hearing in the future for the purpose of acting on this recommendation.

The District's Board of Education approved Resolution #05-06:30 on October 4, 2005 which concluded the following:

- 1. That the "Old School House" is not habitable for regular use by students due to State of California regulations.
- 2. That the "Old School House" has fallen into disrepair and would be costly to renovate and may not ever be able to be habitable by students.
- 3. That renovation of the "Old School House" would require the use of funds currently identified for delivery of improvements to students.
- 4. That the District would prefer to have the "Old School House" preserved by an outside agency rather than permanently demolishing the building, with the stipulation that such preservation would be at no cost to the District and that the building would be removed from District property.

The Board of Education reviewed the status of the "Old School House" at their regularly scheduled meeting held Tuesday, November 28, 2006. As a result of this review of status, the Board of Education reaffirmed its position as stated in item #4 above. The District does not possess any documentation presently that would support the historical status of the "Old School House" and intends to continue the next steps for the removal of the "Old School House" from District property in accordance with all legal requirements. The District remains willing to work with the City and/or non-profit organizations to preserve the "Old School







The Mayor declared the Hearing open. City Clerk read proof of publication of notice of said Hrg open Hearing published in the Azusa Herald on February 8, 2007.

Economic Development Director Coleman addressed the Hearing stating that this is a B. Coleman recommendation by Cultural and Historic Preservation Commission to add the Old School House building to the City's list of Potential Historic Landmarks as well as the Survey List of Historic Properties; the property is located at the southeast corner of the Slauson Middle School campus, 403 N. Angeleno Avenue. He provided a brief background stating that in 1983-2004 the General Plan included a list of historic properties which listed the "Old School House" to be preserved; it was identified as the oldest school house. In 2000 the commission drafted a new list of historic properties and historic landmarks and the Old School House was inadvertently omitted from the lists. In November of 2005 it was brought to the attention of the Commission that the Azusa Unified School District was considering to demolish it. In 2006, the Commission asked that the City investigate the feasibility of moving the building in order to preserve it and the AUSD opposes it. Staff has received a letter indicating that the District does not consent to the proposed designation of as a potential historic landmark and requested that the Commission not consider the designation. The Commission has met since then and is requesting to add it to the Survey List as well as the potential List of Historic Landmarks. He talked about the process for adding properties to Survey and Potential Historic Landmark lists and recommended that the subject property be added to the approved Survey List, not to the Historic Landmark list as the School District objects to it.

City Clerk Mendoza read a letter into the record from Mr. and Mrs. Madrigal and from Bradley Frick, Assistant Superintendent, and Business Services of the Azusa Unified School District, who expressed their opposition to the "Old School House" being added to the Potential Historic Landmark List.

Letters read Into record

Mr. Art Morales addressed the hearing voicing his opinion in favor of saving the old school A. Morales house. He suggested it be used as a homework house and that the Azusa Unified School Comments District donate the corner to the City.

Mr. Jorge Rosales addressed the hearing stating that he has had discussions with Board J. Rosales Members and is in favor of trying to get the AUSD to donate the structure to the City; to Comments relocate the site and or demolish it would be too expensive.



RECOMMENDATION TO ADD THE "OLD SCHOOL HOUSE" BUILDING, LOCATED AT 403 N. ANGELENO AVENUE TO THE APPROVED SURVEY LIST

OF HISTORIC PROPERTIES AND TO THE CITY LIST OF POTENTIAL

HISTORIC LANDMARKS.

RECOMMENDATION

That the City Council provide policy direction on the Cultural and Historic Preservation Commission's recommendation to add the "Old School House", located at 403 N. Angeleno Avenue, at the southeast corner of the Slauson Middle School campus, to the approved survey list of historic properties and to the City list of Potential Historic Landmarks. Past precedence has been that the City Council would yield to a property owner's request if they opted not to be listed as a Potential Historic Landmark.

Although staff would concur that the "Old School House" should be added to the approved survey list of historic properties, we recommend that it not be included on the City list of Potential Historic Landmarks, based on the protest by the property owner.

BACKGROUND

The 1983 - 2004 City of Azusa General Plan Historic Preservation Element included a survey list of historic properties and buildings recommended for preservation. That ilst identified the "Old School House" and the original school house site as a site and building to be preserved. The structure was identified as the oldest, still-standing schoolhouse in Azusa, originally located on Fourth Street, between Soldano Avenue and Pasadena Avenue, and later moved to 403 N. Angeleno Avenue. In 2000, as part of a new Historic Preservation Chapter of the Municipal Code, the Cultural and Historic Preservation Commission drafted a new survey list of historic properties along with a list of Potential Historic Landmarks. The "Old School House" was inadvertently omitted from both of these lists.

On November 1, 2005, it was brought to the attention of the Cultural and Historic Preservation Commission that the "Old School House" was being considered for

demolition by the Azusa Unified School District. The building is currently used for storage and has not been well maintained.

On January 17, 2006, the Cultural and Historic Preservation Commission requested that the City Council investigate the feasibility of the City moving the "Old School House" building onto City property in order to preserve it from demolition. The Council discussed the preservation of the building with the AUSD at a joint meeting on January 30, 2006, however, no decision on the disposition of the structure was reached at that time.

A discussion on the nomination of the "Old School House" to the City list of Potential Historic Landmarks was scheduled for a public hearing at the November 21, 2006 Cultural and Historic Preservation Commission meeting. The AUSD, as the property owner, was notified of the meeting in accordance with the Municipal Code. The AUSD requested a cancellation of the meeting to allow consultation with the Board of Education regarding this issue and to allow appropriate representation by District staff at the meeting. The November 21, 2006 Cultural and Historic Preservation Commission meeting was canceled due to a lack of quorum and the issue was continued to the next regularly scheduled Commission meeting on December 19, 2006. When the AUSD was notified that the discussion of the nomination of the "Old School House" was continued to the December 19, 2006 meeting, with a staff recommendation that the discussion be further continued to the January 16, 2007 Commission meeting, the AUSD responded that the School Board would be finalizing the Board direction at their meeting on January 16, 2007 and the City would be notified of the Intent of the School District. The 1/16/07 AUSD letter further stated that the District does not consent to the proposed designation of the "Old School House" as a Potential Historic Landmark and requested that the Commission not Initiate consideration of such designation without the consent of the District,

On December 19, 2006, the Commission discussed the nomination of the "Old School House" at their regularly scheduled meeting and unanimously agreed to recommend that the City Council add the "Old School House" to the survey list of historic properties and to the City list of Potential Historic Landmarks, notwithstanding the objections of the AUSD.

On February 8, 2007, the AUSD sent a letter to the City stating that the District does not possess any documentation supporting the historic status of the "Old School House" and that it intends to continue the next steps for the removal of the structure from District property.

ANALYSIS:

In March 2001, the City Council adopted a Survey List of 96 historic properties. The 96 historic properties were then nominated to the City list of Potential Historic Landmarks. Property owners were allowed to remove their property from the list of Potential Historic Landmarks if they so desired. 38 property owners removed their properties from the City list of Potential Historic Landmarks at that time. Per the Historic Preservation Chapter of the Municipal Code, the Cultural and Historic Preservation Commission may add historic buildings to the survey list of historic properties and may also submit the subject property to the City Council for Inclusion in the Potential Historic Landmark list without the

property owner's consent for nomination. The City Council may approve a nominated property to the Potential Historic Landmark with or without the property owner's consent.

In addition, when a building or property is on the Potential Historic Landmark list, the building is subject to the constraints of the Municipal Code as it pertains to potential historic landmarks. These constraints include a review of any proposed changes to the property or building by the Cultural and Historic Preservation Commission, and recommendations by the Commission to minimize any changes to the property or building. The listing of a building or property on a survey list of historic properties or the City list of Potential Historic Landmarks also triggers California Environmental Quality Act (CEQA) requirements, which would require an environmental review of any proposed demolition or changes to the property or building through an Initial Study and potentially through an Environmental Impact Report (EIR).

FISCAL IMPACT:

The addition of the "Old School House" to the survey list of historic properties and the City list of Potential Historic Landmarks would have no fiscal impact to the City. However, the AUSD has offered to give the "Old School House" to any organization or group that would relocate the facility, at no cost to the District. It remains clear that the cost of rehabilitation, relocation and land purchase necessary to preserve the structure is estimated between \$800,000 and \$900,000 Should the structure remain at its present location, rehabilitation could cost up to \$85,000.
