Project Title: Time Extension of Graeagle Creek pedestrian Bridge Project (Streambed Alteration Agreement No. 1600-2014-0284-R2)

Project Location (include county): The project is located at Graeagle Creek a tributary to the Middle Fork Feather River, in the County of Plumas, State of California; Latitude 39' 45" 54.26°N, Longitude 120' 37" 1.21°W; Township 22N, Range 12E, Section 15, of the Blairsden U.S. Geological Survey (USGS) Quadrangle.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed an extension of Streambed Alteration Agreement number 1600-2014-0284-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Graeagle Community Services District.

The project is limited to the installation of a pedestrian bridge over Graeagle Creek. Construction will include two bridge abutment, pedestrian approaches and a bridge structure. The abutment will be concrete-cantilever footing with concrete wing-walls. The footings will extend approximately 10-feet below the existing grade. The approaches will be imported fill with an asphalt or concrete walking surface. No fill material will be placed in the active channel and no equipment will work in the active channel. The bridge structure, approximately 150-feet long and 12-feet wide, will be placed by crane from one or both sides of the creek. Work will require trimming vegetation, but no trees will be removed.
