Project Title: Fortezzo Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0657-R1)

Project Location (include county): The project to be completed is located within the Van Duzen River watershed, approximately 7 miles northeast of the town of Redcrest, County of Humboldt, State of California. The project is located in Section 16, T1N, R3E, Humboldt Base and Meridian; in the Bridgeville U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 207-321-023; latitude 40.4599 N and longitude 123.8522 W.

Project Description: The project is limited to six encroachments. One encroachment is for water diversion from a Class II stream. Water will be used for domestic use and irrigation. Work for the water diversion will include modification, use, and maintenance of the water diversion infrastructure. Two encroachments are to upgrade or decommission existing stream crossings. Three encroachments are to restore stream flow impacted by legacy logging. Work for these encroachments will include some of all of the following; excavation, culvert removal, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
