**Project Title:** Martin Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2018-0682-R1)

**Project Location (include county):** The project to be completed is located within the China Creek and Redwood Creek watersheds, approximately 3 miles west of the town of Briceland, County of Humboldt, State of California. The project is located in Section 15, T4S, R2E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 220-051-035; latitude 40.1111-N and longitude 123.9404 W.

**Project Description:** The project is limited to two encroachments. The first encroachment is water diversion from a spring. The second encroachment is water diversion from an unnamed tributary to China Creek. Water is diverted for domestic use. Work for the water diversion will include modification, use, and maintenance of the water diversion infrastructure. There is also a well on parcel which is used for cannabis irrigation on property.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.
