Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2018-0864-R1, pursuant to Section 1602 of the Fish and Game Code to Milojkovic Rados. The project consists of six encroachment(s): Four encroachments are to upgrade failing and undersized culverts. Work for these encroachments will include excavation, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. One encroachment is to maintain a rocked ford crossing. Work for this encroachment will include rock armoring as necessary to minimize erosion. One encroachment is to install a French drain at the base of a graded cutbank that will direct water towards the head of a Class III watercourse, the natural flow path.
