Project Title: Whitmire Streams and Water Impoundment Project (Lake or Streambed Alteration Agreement No. 1600-2018-0648-R1)

Project Location: The project to be completed is located within the Mattole River watershed, approximately 8 miles west southwest of the town of Redway, County of Humboldt, State of California. The project is located in Section 33, T04S, R02E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 220-191-029 and 220-191-027; latitude/longitude: 40.0626, -123.9615 at one stream crossing.

Project Description: The project is limited to three (3) encroachments (Table 1). Two proposed encroachments are to retroactively permit two crossings that were installed in 2017 without a permit. Work for these encroachments included excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. The third encroachment is to retroactively permit the spillway and channel modifications for a reservoir that discharges into and encroaches into the stream bank of an unnamed tributary to McKee Creek. The Permittee shall monitor the reservoir for potential failure.

The Notification also discloses the use of a well located at Lat/Long 40.0638, -123.9581. This well is presented as the sole source of water for irrigation of commercial cannabis and other irrigation needs on the property. The map provided indicates there are two wells present. CDFW did not evaluate hydraulic connection of the well to surface water, nor was a hydrogeologic evaluation prepared by a licensed geologist provided for CDFW review.

Permittee shall monitor reservoir and outlet channel for signs of
failure.
Permittee agrees to implement a Bullfrog Management Plan.
No stocking of fish is authorized by this Agreement.

The Notification also discloses a surface water diversion capable of withdrawing at 9 gallons per minute from McKee Creek located at Lat/Long: 40.0629, -123.9628. The onstream water diversion is presented as only being used for domestic water needs, and not for commercial cannabis or other commercial irrigation. However, Permittee declined to permit this water diversion in this Agreement, opting for a separate LSAA notification that is still in process with Sanctuary Forest, Inc., a nonprofit organization. This Agreement does not authorize this or any water diversion from McKee Creek or other surface waters.

The Notification also discloses a ditch relief culvert that is hydrologically connected to McKee Creek located at Lat/Long: 40.0643, -123.9627. CDFW shall inspect this feature and if work is deemed necessary, Permittee may need to notify.

No other projects that may be subject to FGC1602 were disclosed. This Agreement does not retroactively permit any stream crossings, water diversions or other encroachments not described in Table 1 above.

This is to advise that CDFW, acting as in the Lead Agency / in a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
